


# Stock Dog Cow Camp with Terry Wofford



June 17<sup>th</sup>, 18<sup>th</sup>, 19<sup>th</sup>, 2014

**At Otter Creek and Tucker Creek Farm, Thunder Bay, Ontario**

**LOCATION:** RR#3, 3020 Thunder Bay, Ontario – Tucker Creek Farm, Tanya Wheeler home, Thunder Bay, Ontario. Likely we will also work at Otter Creek Farm on Blake Scoble Road as well.

**TIME:** 8:30 am. Lunch and refreshments will be available to purchase on site.

**COST: With a Dog: \$120.00/dog per day includes lunch.** Preference given for entering all three days.

**Spectators:** \$50.00 per day or \$80.00 for two days and \$120.00 for three days. .

**ENTRY LIMIT:** One entry per day for each handler. Limit of 10-12 dogs each day divided between handlers. This may allow each dog to work once in the morning and once in the afternoon following a lunch break. This schedule may vary. No limits on spectators wishing to audit the clinic or just to sit and relax.

**DEADLINE:** Limited entry, first come first served for entered dogs and no deadline for spectators.

**Terry Wofford:**

Terry hails from Georgia originally and spent his childhood and most of his life around animals. He raised and trained a variety of breeds including 30 years of raising his own line of Catahoula Leopard Dogs. Terry and his partner now reside in Florida and both are certified AKC herding trial judges and provide clinics around the continent and offer lessons from their home in Hilliard, Florida.

Terry has vast experience with livestock as a rancher/handler, as a trainer and a dog handler. He currently owns two Australian Shepherds and has been a qualifier and finisher in the ASCA stockdog finals for several consecutive years with his dog "Mule", Terry has experience with many breeds and he himself has kept and trained Kelpies, Catahoula's, Aussies and other breeds. Terry is noted for his ability to work with people quietly while establishing confidence in the dog and handler. His years of experience with all livestock, and cattle in particular make this a special opportunity to work with a livestock person who sees things as they should be viewed, from the livestock and the dog's point of view. He will help develop your handling skills with the livestock and with your dogs.

## A Clinic Designed to make you a Better Cattle Dog Handler

This clinic is designed for dogs with some experience on stock. Terry is an excellent handler but what makes him unique is his combined experience training dogs but ALSO working dogs with cattle. Terry has not just trialed dogs on cattle but has worked with them for years as useful partners managing a real cattle operations. The combination is a rare treat to work with. He can handle dogs and handlers with little to a lot of experience on cattle.

If you have been waiting for an opportunity to work with someone who can build YOUR CONFIDENCE and your dog's confidence around cattle, this will be a lot of fun for both you and your dog.

The cattle used are worked by dogs every day and are quite dog broke. They are not small calves. These are adult and yearling Simmental cattle on a working farm.

I also agree to pay the full market value (\$200.00 for sheep and \$25.00 for ducks), of any livestock death resulting from my dog's actions, whether willful or accidental, or in the case of injury to any livestock, resulting from the dog's actions, I agree to pay all veterinary fees up to the market value of the animal.
